DPW Supervisor Campbell replaced the cable with a chain. He spoke to neighbors of the park, and they had not seen anything.

Oil & stone projects have been completed. Paving should be completed by the end of September.

Bob Wolf reported on July 4th in celebration of the 100th Anniversary hot dogs and water were handed out. Mr. Wolf reported that he has met people from 30 states and 17 countries on the trail.
