HARDWICK TOWNSHIP PLANNING/LAND USE BOARD JANUARY 12, 2023

There was a reorganization and regular meeting of the Hardwick Township Planning/Land Use Board on Thursday, January 12, 2023. The meeting was called to order at 7:01 p.m. by Attorney Gavan. He led the Board in the Pledge of Allegiance and he stated that proper notice of this meeting has been given in compliance with the "Open Public Meetings Act". #22-009 Princeton Blairstown Center, Block 401, Lot 7- Hearing

Attorney Roger Thomas represented the applicant Princeton Blairstown Center. A revised plan has been submitted since the last French & Parrello report.

Jody Zengulis Vice President of Princeton Blairstown Center was sworn in. Mr. Zengulis stated that the purpose of the application was to construct a 45 X 60 maintenance shed which will be a pole barn with a metal roof, board and back siding, concrete floor and windows all around for natural light. The shed will be used for season purpose to store equipment, canoes and paddle boards in the winter months. The shed will be built near an existing building that has a natural driveway and in a location that will not interrupt any camps that are taking place when equipment is needed and will have no utilities in the building. A motioned solar light will be over the man door that will not be facing towards any residential property that is not owned by Princeton Blairstown Center or main roadway.

Chairman McKim asked the board if there were any questions.

Vice- Chairman Hughes did not know which wall was what from the orientation. Mr. Zengulis pointed out where the garage doors.

Engineer Williams asked how many trees will be taken down. Mr. Zengulis responded that 24 trees will be taken down. 12 are either dead or ash trees. The other 12 will be replaced.

Motion made by Hughes, second by Meuse and carried to open for public comment. No public comment

Princeton Blairstown Engineer Daniel Davis owner operator of Davis Engineering in Newton was sworn in.

Mr. Davis stated that drywells will be installed that will eliminate storm water runoff. Mr. Davis showed the board from pictures he had displayed where the garage doors and man doors will be located.

Township Engineer asked if the shed was within any wetland area? Mr. Davis stated that it was not.

Chairman McKim asked if and fill will be brought in for this project. Mr. Davis stated that there is enough fill on the property.

Motion made by Jacksic, second by Hughes and carried to open to public comment. No public comment.

Motion made by Hughes, second by Meuse and carried to close public comment.
